

Living Water Ministries / Michi-Lu-Ca Release, Waiver, and Indemnity Agreement

It is the intention of Parent or Guardian of Minor by this agreement to exempt and relieve Living Water Ministries and Michi-Lu-Ca Conference Center and Camp (MLC) and their officers, agents, servants, or employees from liability for personal injury, property damage or wrongful death of Name of Minor caused by an act of negligence of Living Water Ministries or MLC and its officers, agents, servants, or employees.

For and in consideration of permitting Name of Minor to observe, or use any facility or equipment of Living Water Ministries or MLC, or engage in and/or receive instruction in any activity or activity incidental thereto some of which may involve dangers and risk of bodily injury at: MLC in the village of Fairview, county of Oscoda and state of Michigan, beginning on the day of DATE, the undersigned parent and/or guardian of Name of Minor hereby voluntarily and absolutely releases, discharges, waives and relinquishes any and all loss or damages or actions or causes of action for personal injury, property damage or wrongful death occurring to Name of Minor as a result of Name of Minor's observing or using facilities or equipment of Living Water Ministries or MLC, or engaging in or receiving instructions in any activities some of which may involve dangers and risk of bodily injury or in activities incidental thereto wherever or however the same may occur, and for whatever period said activities or instructions may continue.

The undersigned parent or guardian of Name of Minor for him/herself, his/her heirs, executors, administrators or assigns agrees that in the event any claim for personal injury, property damage, or wrongful death shall be prosecuted against Living Water Ministries or MLC or its officers, agents, servants, or employees, the undersigned parent or guardian will indemnify and hold harmless Living Water Ministries or MLC and their officers, agents, servants, or employees from any and all claims or causes of action by Name of Minor or by any other person or entity, by whomever or wherever made or presented, and under no circumstances will the undersigned parent or guardian of Name of Minor present any claim against Living Water Ministries or MLC and said persons for personal injuries, property damage, wrongful death or otherwise, caused by an act of negligence by Living Water Ministries or MLC and said persons.

The undersigned parent or guardian represent that he/she has read this release, has requested and has been provided with, or has requested and declined advisement on the potential dangers/risks of engaging in the observation, activities or instruction offered, assumes all risks associated with such dangers and risks, and is fully aware of and understands the terms and the legal consequences of the signing of this Release. The undersigned parent or legal guardian intends his or her signature to be a complete and unconditional release of all liability to the greatest extent allowed by law and if any portion of the Release is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
